PLEASE NOTE THE FOLLOWING IF YOU HOLD AN EXPIRED LEVEL 2/3 OR LEVEL 4 CERTIFICATE

Beginning June 01, 2006, if a technician has allowed his Level 2/3 or Level 4 certification to expire (by even 1 day) then he must request to be enrolled in an online **TLS Startup/Service Exam** (the start-up exam will cost **\$75.00 (Canadian) each**) this would be equivalent to the knowledge that a Level 2/3 technician should have. He will only be allowed to retake the exam once; if, on the second attempt, he fails the exam then he must complete a full 3 day Level 2/3 course with an instructor to become re-certified.

If he passes the Startup/Service Exam, he will be able to enroll in a Level 4 Recertification Course. Keep in mind that simply passing the Startup/Service Exam will **NOT** re-certify the technician – he must **complete** and **pass** a **Level 4** Course. The exam only services as a prerequisite for an expired technician to be able to enroll in a Re-certification Course, either in the classroom with an instructor or On-Line.
